



Q1 Statistical Report 2020 Summary

Overall Quarter 1 Observations

- Calls were received from all four UK Countries and spanned 39 police forces across England and 3
 police forces in Wales.
- Romania was the highest recorded potential victim nationality for England (119). The highest recorded nationality for Scotland was also Romania (3).
- January saw the highest number of calls in Quarter 1, whereas February had the highest number
 of webforms and apps. February 2020 showed a 27% increase in Helpline Calls and a 138%
 increase in Webforms as compared to February 2019.



Over the past 3 months the Helpline received 2176 Helpline calls, webforms and app submissions. Quarter 1 2020 saw a 61% increase in webforms from Quarter 1 2019.



January saw the highest number of Modern Slavery cases reported in the quarter. The highest number of potential victims were also indicated in January. However, February was the busiest month of the quarter for calls, webforms and app submissions. In March 2020, the UK went into lockdown due to COVID-19, which is likely to have impacted contacts into the Helpline.







Indicators of modern slavery reported to the Helpline include, but are not limited to, passport confiscation, little or no pay, debt bondage, isolation, monitoring and physical abuse. Many of the general information cases relate to requests for Helpline materials and media interviews. 23% (171) of non-modern slavery cases relate to potential labour abuse, payment issues or employment contract concerns. Modern slavery cases reported to the Helpline may be from various locations in the UK or even abroad and may not be city or town specific.

Labour exploitation is repeatedly the most common type of exploitation reported. Criminal exploitation made up 9% of modern slavery cases in Q1 2020, the same as Q4 2019. 'Various' is selected when more than one type of exploitation is reported. Cases with 'unknown' exploitation type may result from a technical assistance call with a professional dealing with a victim where the specific details of exploitation the type are not disclosed on the call.




935 Referrals and Signposts




The number of referrals and signposts increased by 20% compared to the same quarter in 2019. These include actions on Non-MS cases, which may be made for other crimes indicated or Non-MS related safeguarding concerns. Cases may have more than one referral or signpost.

Proximity of Caller to the Victim(s) in Modern Slavery Cases




The majority (60%) of callers on modern slavery cases were either involved someone in direct contact with the victim (46%) or the victim themselves (14%). Callers in direct contact with a victim may include an NGO, friends or family of the potential victim, health professional, police, or social services. Indirect contact is recorded where the caller knows of the situation or the individual involved. 'Observation of suspicious activity' refers to third party tip offs, where often limited information is known. A case may have one caller.

Types of Criminal Exploitation




Drugs and begging continue to be the most commonly reported activities for cases of criminal exploitation. This quarter showed 11% of criminal exploitation cases involving other crimes, such as theft and other types of fraud.

Gender of Potential Victims of



The gender of potential victims is recorded by the Helpline where this is provided by the caller. If the caller is unable to specify the gender of indicated victims, 'unknown' is recorded.

Age of Potential Victims of **Modern Slavery**



Potential victims' ages are recorded based on caller information. If the caller does not know the age of the victim, 'unknown' is recorded. In all cases, the Helpline seeks to establish if a minor is involved in a situation.




936 Potential Victims of Modern Slavery

The Helpline may receive multiple calls about one case. Calls relating to cases of modern slavery reportedly occurring in England are recorded above, even though the caller may be calling from another country. Sometimes callers speak in general terms about cases in England but may not specify a particular area or location.

Along with calls on modern slavery cases, the 767 calls reported to occur in England may also be for non-modern slavery or general information cases with a reported caller location of England.

This quarter shows an overall 38% increase in the number of s modern slavery cases reported to have occurred in England from Q1 2019. Despite the increase in the number of cases, O1 2020 saw a similar proportion of cases relating to labour exploitation (50%) as Q1 2019 (54%), sexual exploitation (17% 2020 vs 15% 2019), criminal exploitation (9% 2020 vs 10% 2019), and domestic servitude (6% 2020 vs 8% 2019).









Quarter 1 2020 saw a 29% increase in calls relating to cases in Scotland than quarter 1 2019, and a significant 50% increase in webforms. Modern Slavery cases more than quadrupled in quarter 1 2020 compared to the same quarter in 2019 (13 vs 4).





Type of Exploitation




In quarter 4 2019, 93% of modern slavery cases reported in Wales referred to labour exploitation. Quarter 1 2020 saw labour exploitation make up 37% of modern slavery cases, with criminal exploitation contributing 25%. In 2 cases, the type of exploitation was unknown.




16 Potential Victims of Modern Slavery



In quarter 4 2019, the 2 cases of modern slavery reported in Northern Ireland reported 1 case of labour exploitation and 1 case of criminal exploitation. Quarter 1 2020 has seen a broader mix of modern slavery cases, including cases of sexual exploitation which make up 40% of the cases.
